IN 2016, PARK PRIDE PROVIDED ONGOING SUPPORT FOR 22 NEIGHBORHOOD GROUPS AND NON-PROFIT ORGANIZATIONS THAT HAVE ESTABLISHED COMMUNITY GARDENS IN CITY OF ATLANTA PARKS.

FISCAL PARTNERS

THROUGH THE FISCAL PARTNERS SERVICE, PARK PRIDE ADMINISTERS ACCOUNTS FOR FRIENDS OF THE PARK GROUPS TO RECEIVE CONTRIBUTIONS FOR PARK IMPROVEMENTS. THE PROGRAM HAS ENABLED NEIGHBORHOODS THROUGHOUT ATLANTA AND DEKALB COUNTY TO REALIZE THEIR DREAMS OF NEW PLAYGROUNDS, ENHANCED LANDSCAPING, PARK AMENITIES AND PRESERVED GREENSPACE.

PARK PRIDE COORDINATES THOUSANDS OF VOLUNTEERS EACH YEAR TO HELP MAKE

AREA. CORPORATE, STUDENT, COMMUNITY, AND OTHER NON-PROFIT GROUPS
