PARK PRIDE OFFERS A COMPREHENSIVE STRUCTURE PROVIDING EDUCATIONAL OPPORTUNITIES, CONSULTATIONS AND COACHING, TOOLS, MATERIALS, TRAINING, DESIGN SERVICES, VOLUNTEERS, AND FUNDING, THROUGH WHICH FOP GROUPS CAN IMPROVE THEIR NEIGHBORHOOD PARKS.

IN 2020, PARK PRIDE SUPPORTED 161 FOP GROUPS STEWARDING 213 PARKS THROUGHOUT THE CITY OF ATLANTA, UNINCORPORATED DEKALB COUNTY, CITY OF BROOKHAVEN, AND CITY OF TUCKER. THE PROGRAM WORKS TO BUILD INDIVIDUAL LEADERSHIP SKILLS AND COMMUNITY CAPACITY SO THAT RESIDENTS CAN CREATE A POSITIVE IMPACT IN THEIR COMMUNITY. PARK PRIDE ALSO CONNECTS FOP GROUPS
