PARK PRIDE Questions

1. Campagnolo is an Italian bar & restaurant located at 980 Piedmont Avenue. The management & staff were kind enough to let me broadcast via Zoom from there for the Greenspace Mayoral Forum. Hospitality workers often work late hours. When they get home, they do their chores, such as take their dog out for a walk. That is why Katie Janness was walking her dog at a late hour in Piedmont Park on the night of her brutal murder. During the Greenspace mayoral Forum, I tilted my computer so that Atlanta voters could watch her colleagues at work.

A cornerstone of my political platform is to constitute the Milledgeville Rocket Docket at Atlanta Municipal Court. Judge Hagenau can nullify the Gulch bond deal, which would greatly reduce the property taxes for hardworking Atlanta homeowners. We can get through this together.   - a. The repeated attempted theft of the Atlanta Airport by certain state legislators.
  - b. Systemic threats to the integrity of the Atlanta Banking System.
  - c. The racketeering activity of the Fulton County Development Authority
