






## Who We Are




# Removal Happened **1n** Various Phases





1826 - Treaty resigned under the Treaty of Washington



#### 116th Congress

#### An Act

To provide for the management of the natural resources of the United States, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE; TABLE OF CONTENTS.

(a) SHORT TITLE.—This Act may be cited as the "John D. Dingell, Jr. Conservation, Management, and Recreation Act".

#### **Special Resource Study for Ocmulgee National Park and Preserve**

"The study required under paragraph shall be conducted in accordance with section 100507 of title 54, United States Code.


REPORT.—<u>Not later than 3 years after the date on which funds are first made available to carry out the</u> <u>study</u> under paragraph the Secretary shall submit to the Committee on Natural Resources of the House of Representatives and the Committee on Energy and Natural Resources of the Senate a report that describes the results of the study; and any conclusions and recommendations of the Secretary [of Interior]."




